VOLUNTARY SKIP PAYMENT REQUEST AND AUTHORIZATION

In this Request and Authorization, the reference to "Us," means the Lender. The words "You" or "Your" mean each person accepting this Agreement. If this is a joint account, read singular pronouns in the plural.

Instructions: Except for members not in good standing, loans that have been open less than six months and any real property secured loans, You may request to skip a month's payment once during any six consecutive payment period. In order to request a skip payment, You must complete the Voluntary Skip Payment Request And Authorization form below in its entirety, and return it to Paradise Valley Federal Credit Union signed by each Borrower listed on the loan.

The request must be sent to Us via facsimile machine at (619) 475-4313 or mailed to Paradise Valley Federal Credit Union, 2700 E. 4th Street, National City, CA 91950. Regardless of the delivery method chosen, such request must be received by Us prior to the due date of the month's payment that You wish to skip, and will not be valid unless and until, Your request is approved by Us.

You understand that interest will continue accruing on the unpaid balance of Your loan at the Simple Interest Rate designated in Your Agreement until Your balance is paid in full, and that skipping a payment will have the result of increasing the total amount of interest paid, in which case You may be required to make a lump-sum balloon payment on Your originally scheduled maturity date. You further understand that the \$_____ (per loan) skip payment fee is a FINANCE CHARGE that is part of the skip payment process and is not optional.

Guaranteed Asset Protection Insurance ("GAP"). If You have GAP on one or more of the loans in which payment is being skipped, You understand that the act of skipping or otherwise deferring such payment(s) will have no effect on the original terms and conditions of the GAP waiver. Further, any payment skipped means that a payment is not paid in accordance with the original terms of the applicable loan agreement and since GAP does not cover the amount of any payments skipped during the life of the subject loan, such payment amounts will be deducted from any GAP benefit that would otherwise be payable in the event of a claim.
